Structure & Assessment

The programme is based on a modular structure. There are 3 modules, each lasting 3 days. Delegates can attend individual modules.

Postgraduate certificates will be awarded upon completion of all 3 modules. The course can be completed within the first running of the programme or over a period of up to 24 months throughout which the course will have been repeated.
